#### 1. Background:

Transparency International Cambodia (TI Cambodia) was officially founded on 5<sup>th</sup> July 2010 and has officially registered with the Royal Government of Cambodia in July 2011. The mission of TI Cambodia is to work together with individuals and institutions at all levels to promote integrity and reduce corruption in Cambodia through the following areas:

- Promote individual and institutional best practices and integrity in their day-to-day performance through education and sharing of good models and examples.
- Empower community members to actively engage in monitoring development processes at national and sub-national levels.
- Advocate for positive changes toward a corruption free society.

TI Cambodia is seeking a Legal Expert to conduct legal analysis on the current Anti-corruption legal framework, particularly Law on Anti-Corruption and Criminal Laws, and other related regulations of Cambodia. The expert will work closely with TI Cambodia lawyer to define the analytical framework, scope, and review of the materials and design the lay-out and format of the paper. The format of the paper must be a friendly reading and used as educational materials for training or workshop or other distribution purposes.

#### 2. Deliverable:

Legal expert will produce a succinct legal analysis paper and preferably on a leaflet format.

#### 3. Role and Responsibility

The primary tasks of Legal Expert are to:

- Develop layout/structure of analysis by working with TI Cambodia's Lawyer
- Review the current legal framework, particularly Anti-corruption law and criminal code and other related regulations.
- Conduct the analysis with the agreed structure and scope.
- Produce drafted analysis paper (with required format) and share with team for feedback.
- Finalise the product
- Contribute and/or provide presentation at the launch of the paper (if needed).
