

## 5. GOVERNANCE FOUNDATION AND CAPACITY STRENGTHENING

We ensure that TI Cambodia lives up to its principles and international standard by practicing the most effective and efficient governance system, which guarantees strong checks and balances. We equip TI Cambodia with all necessary policies, guidelines and regulations. We foster a culture of dialogue and openness among staff members, and enhance their ability to deliver results more effectively. In the next three years, we transform TI Cambodia to become a membership-based organisation and its members will be empowered to participate in democratic decisions of TI Cambodia.

## 6. RESEARCH AND ADVOCACY

We diagnose the root causes of corruption and using internationally recognised methods to analyse the impacts of corruption on Cambodia. We work with relevant partners to conduct a study on corruption in public services. We will conduct a second study on the National Integrity System and launch a new study on the Business Integrity Country Assessment (BICA). Together with TI Movement and local partners, we conduct a study on extractive industry licensing process. An empirical study on "Judicial Corruption" will also be conducted in partnership with relevant government institutions and partners. The findings and recommendations will be used to promote democratic reforms and stimulate public debates on the issues.

## 1. PUBLIC SECTOR ENGAGEMENT AND REFORM

We engage very constructively with relevant government institutions at the national and sub-national levels to promote integrity, accountability and transparency in the public sector. As partners, we enhance capacity of government officials to provide public services more effectively to citizens. We also support the government's reform efforts to improve relevant legal and regulatory frameworks.

## 2. PARTNERSHIP AND COALITION BUILDING

We enhance partnership with key Non-Governmental Organisations and strengthen their capacity to demand collectively for transparency, integrity and anti-corruption. Together with key CSO Working Groups, we advocate for an open government, budget transparency, access to information and extractive industry transparency. We also partner with the Election Reform Alliance and the National Election Committee (NEC) to promote transparency and integrity in election.

## 3. CITIZEN AND YOUTH EMPOWERMENT

Moving beyond awareness raising, we promote democratic participations by citizens and youths in making decisions that affect their lives. We empower citizens and equip them with skills and tools to promote integrity among their peers and demand for transparency and anti-corruption. We work together with citizens and youths from across Cambodia to form a Social Movement Against Corruption and strengthen public demand for accountability and transparency. Youths will be empowered to take actions on issues that concern them, their community and society as a whole.

## 4. PROMOTING BUSINESS INTEGRITY

Together with the private sectors including National and International Chambers of Commerce and Small and Medium Size Enterprises (SMEs), we promote integrity in businesses through capacity building on business compliances and promoting the Corporate Integrity System (CIS). We will also conduct studies on corruption in businesses and use the findings and recommendations to promote reform and advocate for a better enabling environment for business to thrive.
