



- Cambodia receives a score of 24 on the CPI 2022
 - An improvement of one point compared to 2021
- Cambodia now ranks 150th out of the 180 countries/territories included in the Index
 - The country ranked 157/180 last year
- Now occupies the second lowest spot in ASEAN and remains the third lowest in Asia Pacific Region
 - Continues to be perceived as highly corrupt

CAMBODIA'S CPI SCORES COMPARISON OVER THE YEARS (2012 – 2022)









2. Asian Intelligence	Political and Economic Risk Consultancy (PERC)	Assessment of risks, with a focus on critical socio-political variables including corruption, intellectual property rights risks, and labor quality.
3. Global Insight Country Risk Ratings	Global Insights (GI)	Political risk analysis of events impacting business, investment, and economic climates worldwide.
4. Economist Intelligence Unit Country Risk Service	Economist Intelligence Unit (EIU)	Analysis of political, economic policy and economic structure risks worldwide.



5. The Varieties of Democracy Index	The V-Dem institute (V- Dem)	Include information on hundreds of indicators on all aspects of government, especially on the quality of democracy, inclusivity, and other economic indicators
6. World Justice Project Rule of Law Index Expert Survey		A portrait of the rule of law worldwide by providing scores and rankings based on eight factors, including constraints on Government Powers and Absence of Corruption.
7. Bertelsmann Stiftung Transformation Index	Bertelsmann Stiftung	Analyzes and compares transformation processes towards democracy and a market economy worldwide
8. World Bank Country Policy and Institutional Assessment	World Bank	Assess the conduciveness of a country's policy and institutional framework to poverty reduction, sustainable growth, and the effective use of development assistance.






COMPARISON OF DATA SOURCES FOR CAMBODIA 2021-2022



CPI 2022 (ASEAN Countries)






CPI 2021-2022 (ASEAN Countries)



KEY RECOMMENDATIONS



Key recommendations of TI Cambodia are:

- 1. Sanction corrupt behaviors and offenses, both grand and small-scale, and ensure that corruption is a high risk and a low gain venture through an effective enforcement of the anti-corruption legislations.
- 2. Uphold the rights needed to hold power to account. The government should end restrictions on freedoms of expression, association and assembly and ensure justice for crimes against human rights defenders must also be an urgent priority.
- **3. Restore and strengthen institutional checks on power.** Public oversight bodies need to be independent, well-resourced and empowered to detect and sanction wrongdoings.
- 4. Amend/adopt anti-corruption legislations/provisions and ensure that it meets international standards and practices.
- 5. Adopt the Access to Information law that meets the international standard and promote the right to information.
- 6. Promote fair competition and better level playing field for the private sector including promoting corporate ownership transparency, advancing transparency in public procurement and promoting equal compliance.
